Summary

The VIP Series focuses on federal grant-in-aid programs in the FFIS database that are of most importance to states. While FFIS tracks more than 240 grant-in-aid programs, the lion's share of federal aid, about 75% of total funding tracked by FFIS, is reported here.

This edition of *The VIP Series* estimates the impact of the president's proposed budget for fiscal year (FY) 2019, which was released on Monday, February 12. It also includes updated grant allocations for FY 2017. While it provides FY 2018 estimates, they are based on a continuing resolution (CR), which includes an across-the-board rescission for discretionary programs (-0.6791%), rather than final appropriations. For mandatory programs, FY 2018 estimates reflect current-law levels.

Figures reflect the impact of mandatory sequestration on non-exempt programs under the Budget Control Act (BCA; P.L. 112-25). Reduction percentages are specified in the footnotes for the affected programs.

As it does every year after the president's budget is released, FFIS will prepare a *Budget Brief* with additional information from the FY 2019 proposal. Since this budget was compiled before enactment of the Bipartisan Budget Act of 2018 (BBA), its discretionary totals are lower than the spending caps set in the BBA. An addendum to the budget proposed additional spending for certain programs to reflect the higher caps, which is reflected in the estimates reported for FY 2019. The BBA also increased FY 2018 discretionary caps, so final funding levels for that year are likely to differ from those reported here.

Once final FY 2018 appropriations are completed, FFIS will update all the programs in its grants database to reflect both FY 2018 and FY 2019 actions. That update will be provided to database subscribers and available at www.ffis.org.
