COMMERCE

Senate Committee Approves EDA Reauthorization

On November 18, 2009, the Senate Environment and Public Works Committee approved the Economic Development Revitalization Act of 2009 (S. 2887), which would reauthorize the Economic Development Administration (EDA) for fiscal years (FYs) 2009-2013. The bill would authorize \$500 million per year for the EDA to provide development grants to economically distressed communities to promote jobs and businesses in those communities most in need. The current authorization for EDA expired on September 30, 2008. The bill now goes to the full Senate for consideration. The House held a hearing on EDA reauthorization in March, but a reauthorization bill has not been introduced during this Congress.

HEALTH AND HUMAN SERVICES

1) Senate Approves Motion to Begin Health Care Reform Deliberations

On November 21, 2009, the Senate approved a procedural motion that allows the chamber to move to debate the comprehensive health care reform bill introduced by Senate Majority Leader Reid last week. Debate is scheduled to begin on November 30, 2009, and is expected to last through most of December. The Senate bill includes an individual mandate to obtain coverage and financially penalize employers who offer no or unaffordable coverage to their employees. The proposal also would establish health insurance exchanges, provide sliding scale federal subsidies to assist low-income individuals with income between 133% and 400% of the federal poverty level (FPL) afford coverage, expand Medicaid eligibility to 133% of FPL for all non-elderly individuals, and impose an excise tax on high-cost health insurance plans, as well as other fees. The federal government would pay all the costs of covering newly eligible Medicaid enrollees from 2014 through 2016. Beginning 2017, states would pay a share of the costs, which would average about 10%. According to the preliminary analysis by the Congressional Budget Office (CBO), the bill would reduce the federal budget deficit \$130 billion over its first 10 years (2010-2019). 2) CMS Releases Letter on Individually Directed Goods and Services

On November 19, 2009, the Centers for Medicare and Medicaid Services (CMS) released a State Medicaid Directors letter providing guidance to states for their use in determining the goods and services they will permit to be covered as "individual directed goods and services" under a section 1915(c) Home and Community-Based Services waiver program, or as "permissible purchases" under the section 1915(j) self-directed Personal Assistant Services State plan option. 3) HHS Announces Availability of \$10 Million in Medicaid/CHIP Outreach Grants

On November 19, 2009, HHS announced the availability of \$10 million in grants to enroll eligible uninsured American Indian and Alaska Native children in Medicaid and the Children's Health Insurance Program (CHIP). These grants were included in the Children's Health Insurance Program Reauthorization Act of 2009 (CHIPRA). Applications are due by January 15, 2010, and grants will be awarded on April 15, 2010. Eligible entities include the Indian Health Service and Tribes, Tribal Organizations, and Urban Indian organizations operating a health program. The grant announcement is available at:

4) CMS Withdraws Proposed Rule on Medicaid Rehabilitative Services

On November 23, 2009, the Centers for Medicare and Medicaid Services (CMS) published a document in the *Federal Register* that withdraws a proposed rule published on August 13, 2007, related to the definition of and coverage for rehabilitative services under the Medicaid program. ARRA included a provision stating that it was the sense of Congress that the secretary of the Department of Health and Human Services (HHS) should not finalize the rule. To view the notice, see:

HOMELAND SECURITY

1) FEMA Publishes Final Rule on Public Assistance

The Federal Emergency Management Agency (FEMA) published a final rule in the Federal Register on November 20, 2009, related to the financial assistance it provides to state/local governments and non-profit organizations for response and recovery activities as a result of a major disaster or emergency. Specifically, the rule finalizes the July 2006 interim rule, which amended FEMA's public assistance eligibility regulations to allow grantees to seek reimbursement for eligible sheltering and evacuation costs incurred outside of areas designated under a presidential emergency or major disaster declaration. 2) Firefighter Grant Measure Passes House

On November 18, 2009, the House passed legislation that would authorize \$11 billion over five years for firefighter programs. The bill (H.R. 3791) would authorize \$1 billion annually for FYs 2010-2014 for the Assistance to Firefighters Grant Program. It would also authorize the Staffing for Adequate Fire and Emergency Response Grant Program at \$1.2 billion annually for FYs 2010-2014. FEMA administers both grant programs.

HOUSING

1) Guidance Released on Calculating Operating Subsidies for 2010

On November 19, 2009, the Office of Public and Indian Housing at the Department of Housing and Urban Development (HUD) released guidance that provides public housing agencies (PHAs) with instructions for operating subsidy calculation submissions in calendar year (CY) 2010 as funded from FY 2010 appropriations. 1) TAA Guidance Change on Implementing Trade and Globalization Adjustment Assistance Act of 2009

On November 20, 2009, the Employment and Training Administration (ETA) at the Department of Labor published Training and Employment Guidance Letter No. 22-08, Change 1, that provides operating instructions for implementing amendments to the Trade Act of 1974, enacted by the Trade and Globalization Adjustment Assistance Act of 2009. The guidance provides a correction to the formula for calculating Reemployment Trade Adjustment Assistance (RTAA) payments and to respond to questions from State Workforce Agencies (SWAs) about administration of Trade Readjustment Allowances (TRA) and RTAA under the new Trade Adjustment Assistance (TAA) program, as amended in 2009. 2) BLS Seeks Comments on Revised Methodology for Monthly Labor Force Statistics

Department of Interior Disburses Almost \$11 Billion in FY 2009 from Federal Energy Revenues

On November 17, 2009, the Department of the Interior's Minerals Management Service (MMS) announced that it disbursed almost \$11 billion in FY 2009, of which \$2 billion was provided directly to states and counties, from revenues collected from energy and mineral production on federal and American Indian lands. Public Defender Offices, 2007 Statistical Tables Released

On November 19, 2009, the Department of Justices Bureau of Justice Statistics (BJS) released Public Defender Offices, 2007 Statistical Tables, which examines offices that provide representation for indigent defendants through attorneys who are employed as direct government employees or through a public, non-profit organization. Public defender offices are categorized according to whether they are principally funded and administered at the state government level, county level, or through a combination of both. NUTRITION

1) SNAP Guidance Issued on Unreported and Unverified Expenses

On November 18, 2009, the Food and Nutrition Service (FNS) at the Department of Agriculture released clarifying guidance on Supplemental Nutrition Assistance Program (SNAP) application statements about unreported and unverified expenses. The FNS guidance provides information on six issues for those state agencies that choose to include on their applications a statement notifying applicants that failure to report or to verify expenses indicates that a household does not want to receive a deduction for that expense. 2) USDA Report on Food Insecurity Released

On November 16, 2009, the Department of Agriculture's Economic Research Service's (ERS) released its annual report on household food security in the U.S., which revealed that in 2008, 17 million households, or 14.6%, were food-insecure and families had difficulty putting enough food on the table at times during the year. This is an increase from 13 million households, or 11.1%, in 2007. The 2008 figures represent the highest level observed since nationally representative food security surveys were initiated in 1995. GENERAL

GAO Finds Good and Bad in Stimulus Reports

An official with the Government Accountability Office (GAO) told Congress that while recipient reporting of federal stimulus dollars went relatively smoothly, errors were made. In a report released on November 19, 2009, GAO cited projects in which jobs were reportedly created but no funds expended; projects with nearly \$1 billion spent but no jobs created; and inconsistency in the guidance and counting of Full-Time Equivalents (FTEs). GAO aimed several of its recommendations at the Office of Management and Budget (OMB), which spearheaded the regulatory process for ARRA. Specifically, GAO said that OMB should "(1) clarify the definition and standardize the period of measurement for FTEs and work with federal agencies to align this guidance with OMB's guidance and across agencies; (2) given its reporting approach, consider being more explicit that 'jobs created or retained' are to be reported as hours worked and paid for with Recovery Act funds, and (3) continue working with federal agencies and encourage them to provide or improve program specific guidance to assist recipients, especially as it applies to the full-time equivalent calculation for individual programs." SNAP Guidance Released on \$25 Supplemental Weekly UI Compensation

On November 19, 2009, the Food and Nutrition Service at the Department of Agriculture (USDA) released information on implementing a recently enacted provision, included in the Worker, Homeownership, and Business Assistance Act of 2009 (P.L. 111-92), that changes the treatment of the \$25 supplemental weekly unemployment compensation payment authorized by ARRA.
